Section 10.2.1 (14)
Management Objective - Policies and Actions
Accommodation

Replace the wording in the **first dot point** with:

• The bed numbers for the management units must not exceed 10,433 beds:

Replace the wording in the second dot point with:

- The bed numbers for each alpine resort management unit must not exceed:
 - Perisher Range Management Unit by 4952 beds;
 - Thredbo Management unit 4820 beds;
 - Charlotte Pass Management Unit 611 beds
 - Selwyn Management Unit 50 beds (essential servicing staff only including a minimum of 4 beds for the volunteer ski patrol)
